I PULLED OUT OF A GAS STATION ONTO A MAJOR BUSY STREET AND ACCELERATED THE CAR AND PASSED A MAJOR BUSY INTERSECTION. AS I ACCELERATED THE VEHICLE, I HEARD A LOUD BOOM COMING FROM THE FRONT OF THE CAR AND WAS STARTLED BY THE LOUD BOOM. AS I PASSED THE INTERSECTION I NOTICED THAT ALL OF A SUDDEN I HAVE NO CONTROL OF THE STEERING WHEEL WHATSOEVER (IT LOCKED UP). I TRIED TO PULL OVER TO THE RIGHT PASSING SOME PARKED VEHICLES ON THE STREET & THERE WERE A LOT OF VEHICLES BEHIND ME. I MANAGED TO MOVE THE CAR TO THE RIGHT, WITH MY FOOT ON THE BRAKE, WITHOUT HITTING A PARKED CAR IN FRONT OF ME. MY FRONT RIGHT TIRE OF THE CAR CRASHED INTO THE CURB AND STOPPED. THE CAR WAS PARKED AT AN ANGLE I
