DEALERSHIP SAID THEY FOUND NOTHING WRONG WITH IT, HOWEVER THEY ONLY DROVE IT 4 MILES INSIDE CITY LIMITS WHERE THE SPEED LIMIT IS APPROX 25-35 MILES PER HOUR.
