I TOOK THE CAR IN FOR SERVICE ON 12/17/01, (MACS103648, 12/17/01) MY WARNING LIGHT WAS ON (3RD OR 4TH TIME IN PAST 2-3 MONTHS). WHEN THE CAR FIRST STARTS UP I HAVE TO KEEP MY FOOT ON THE GAS, TO KEEP IT FROM STALLING. THIS HAS BEEN A PROBLEM SINCE I FIRST BOUGHT IT, (MACS60450, 5/18/99) BUT THEY TOLD ME IT WAS JUST THE IDLE MECHANISM AND THEY COULDN'T DO ANYTHING ABOUT IT. SINCE IT WENT AWAY, IN SECONDS OF WARMING UP, I DIDN'T MENTION IT AGAIN. IT WENT IN FOR SERVICE THIS TIME BECAUSE IT SEEMED TO BE GETTING WORSE. NOW, WITH THE CAR OFF WARRANTY, THE CHARGE IS \$748.62 TO REPLACE THE VALVE IDLE AI AND THE THERMO GASKET. THEY KEPT MY CAR FOR TWO DAYS TO FIGURE THIS OUT. *AK
