NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

AFTER FILLING GAS TANK, VEHICLE WAS DRIVEN APPROXIMATELY NINE MILES AND WENT FROM A FULL TANK TO LESS THAN A HALF TANK OF GAS. VEHICLE WAS COVERED IN GASOLINE. VEHICLE WAS TOWED TO NEAREST DEALERSHIP FOR REPAIR. AFTER REVIEW OF NHTSA WEB SITE IDENTIFIED THAT THIS IS NOT AN ISOLATED INCIDENT. CONCERNS WERE RAISED WITH REPAIRING DEALERSHIP AS WELL AS SELLING DEALERSHIP. REQUESTED FAILURE ANALYSIS OF FAILED PART TO DETERMINE ROOT CAUSE OF FAILURE, INFORMED THAT DEALERSHIPS DO NOT HAVE PERSONNEL TRAINED TO DO THIS. INFORMED DEALERSHIPS THAT I DO NOT FEEL VEHICLE IS SAFE AND WOULD LIKE THEM TO TAKE THE VEHICLE BACK DUE TO IT ONLY BEING 35 DAYS OLD AND 1700 MILES, TOLD THEM THAT I WOULD CONSIDER THE PI
