THE WINDSHIELD WIPERS TURN ON WHEN NOT SELECTED, AND IS VERY DISTRACTING, AND HAS ALMOST RESULTED IN SEVERAL ACCIDENTS. SOME OF MY FRIENDS WHICH ALSO OWN CARAVAN/VOYAGER HAVE HAS THE SAME PROBLEM AND HAVE HAD THE SWITCH REPLACED NUMEROUS TIMES TO NO AVAIL. I THINK DODGE NEEDS TO REDISGN THE SWITCH, AND RECALL ALL THE EFFECTED VEHICLES AND HAVE IT CORRECTED IMMEDIATELY. ALSO AS FAR AS THE FRONT BRAKES, I HAVE HAD THE FRONT BRAKE SHOES REPLACED AT LEAST 7 TIMES IN THE TIME I HAVE OWNED THE CAR. I HAVEN'T REPLACED THAT MANY BRAKES TOGETHER ON ALL THE OTHER CARS I HAVE OWNED. I THINK THE FRONT DISC BRAKES ARE UNDERSIZED AND CANNOT MEET THE WEIGHT OF THE VAN. DODGE ALSO
