THE FIRST TIME THE WHEEL CRACKED WHILE EXITING INTERSTATE AND RUNNING OVER A SMALL POTHOLE. THOUGHT IT WAS SOMETHING MY DAUGHTER DID. THE SECOND TIME A FEW MONTHS LATER, ANOTHER ONE CRACKED IN THE SAME LOCATION ON THE WHEEL AND CAUSED THE TIRE TO BLOW OUT. CHECKED WITH THE DEALER WHO REFUSED TO TAKE ANY ACTION OR EVEN INVESTIGATE ANY CHANCE OF MALFUNCTION OF WHEELS. SEVERAL MONTHS LATER WHEN HAVING THE CAR SERVICED, WAS TOLD THE OTHER 2 WHEELS WERE BENT CAUSING THE CAR TO VIBRATE WHILE DRIVING AT 55 TO 60 MPH.*AK
