**PROBLEM #1: PASSENGER SIDE SEAT BELT WILL LOCK UP AND NOT RELEASE UNTIL BUCKLE RELEASE IS PUSHED. THE SEAT BELT TIGHTENS SO THAT PASSENGER CANNOT EVEN MAKE SMALL MOVEMENTS, LIKE OPENING THE GLOVEBOX OR OPERATING THE RADIO. THIS IS A SAFTEY HAZARD AS THE SEAT BELT IS PARTICULARIRLY RESTRICTING TO MY PREGNANT WIFE. TO RELEASE THE BELT BY RELEASING THE BUCKLE WOULD BE UNSAFE WHILE THE VEHICLE IS MOVING. BARTON BIRKS CHEVROLET DEALER SAYS BELT IS OF "NORMAL OPERATION AS PER MAKE AND MODEL DESIGN". DRIVER SIDE SEAT BELT HAS NO SUCH PROBLEM HOWEVER. PROBLEM #2: DRIVER AND PASSEGER SIDE POWER MIRRORS WILL CHANGE THEIR POSITIONS AT RANDOM. THIS IS ANOTHER SAFTEY HAZARD BECAUSE OFTEN YOU WILL N**
