I HAVE ALSO BEEN TOLD THIS IS AT MY COST TO FIX, AND I FEEL THAT HONDA SHOULD BE RESPONSIBLE FOR THE FAULTY PART(S) NOT ME. I AM HOPING THAT ENOUGH PEOPLE WILL FILE COMPLAINTS SO THAT HONDA IS ASKED TO PERFORM A RECALL TO FIX THIS PROBLEM. THIS FAILURE CAUSES A FALSE FUEL READING WHICH COULD LEAVE ME STRANDED ON THE SIDE OF THE ROAD BECAUSE I MIGHT THINK I HAVE ENOUGH FUEL TO GO SOME WHERE AND END UP NOT HAVING ENOUGH. THIS FAILURE SHOULD BE HONDA'S COST TO FIX NOT MINE, AND MAYBE BY FILING THIS COMPLAINT ALL OF US WITH THIS PROBLEM
