THIS IS A FOLLOWUP ON ODI 757393 SUBMITTED ON 1/24/2002 AND AMENDED 1/27/2002. UPON TOWED RETURN OF VEHICLE TO SERVICE AGENT REPAIR SHOP, SERVICE AGENT INVESTIGATED VISIBLE GASOLINE LEAK. UPON CAREFUL EXAMINATION OF THE REPLACEMENT VENT ASSEMBLY, SERVICE AGENT REPORTED THAT WHILE THE PART "LOOKED" LIKE THE RIGHT PART; IT INDEED WAS AN INCORRECT PART. THE SERVICE AGENT SAID THE PART WAS PREVIOUSLY PACKAGED AND SHIPPED IN A BOX WITH THE CORRECT PART NUMBER; HOWEVER IN CONVERSATIONS WITH DAIMLERCHRYSLER, IT WAS ONLY THEN DETERMINED TO BE AN INCORRECT PART. THEY COULD ONLY DISTINGUISH THE PART BY ITS VENDOR MANUFACTURER'S "CASTING NUMBER" CAST INTO THE ASSEMBLY. CHRYSLER VERIFIED
