WITHIN ONE WEEK IT WAS HAVING THE SAME "JUMPY" PROBLEM. THEY HAD PREVIOUSLY "LUBRICATED" THE SPEEDOMETER CABLE, WHICH FIXED THE SITUATION FOR A COUPLE OF WEEKS. WE ARE TAKING THE CAR BACK TOMORROW TO SEE WHAT THEY SAY, NOW THAT WE'VE SEEN HOW MANY TAURUS OWNERS HAVE HAD PROBLEMS WITH SPEEDOMETERS.
