NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE FUEL RAIL HAS A MANUFACTURING HOLE AT ITS FRONT END, WHICH IS PERMANENTLY PLUGGED BEFORE INSTALLATION. IN RECENT WEEKS, THIS PLUG BEGAN LEAKING RAW GASOLINE, WHICH IS UNDER HIGH PRESSURE WITHIN THE FUEL RAIL TO SUPPLY FUEL TO THE FUEL INJECTORS. THE SOURCE WAS NOT IMMEDIATELY EVIDENT, UNTIL JANUARY 25TH, WHEN THE FUMES BECAME SICKENING. AT THAT TIME, WE OBSERVED RAW FUEL DROPLETS LEAKING PAST THIS FUEL RAIL PLUG ON THE ENGINE. WE IMMEDIATELY KILLED THE ENGINE. IN TALKING WITH VOLVO DEALERSHIP PERSONNEL, THEY WERE IMMEDIATELY FAMILIAR WITH THE SITUATION, INDICATING THAT THEY HAD SEEN THIS BEFORE. MY IMPRESSION IS THAT IT IS HAPPENING MANY MORE TIMES THAN IT SHOULD, COM
