**NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)**

**THE HIGH SEAT BACKS SEVERELY RESTRICT VISIBILITY. IT IS IMPOSSIBLE TO SEE OUT THE SIDE BACK WINDOWS. THIS IS A SERIOUS SAFETY CONCERN. THE DEALER ADVISED THAT THE PASSENGER SEAT BE MOVED TO ENHANCE VISIBILITY. WE ARE BOTH AVERAGE HEIGHT, AND NEITHER OF US CAN SEE WHEN THE SEATS ARE IN THEIR NORMAL POSITION. THIS IS A MAJOR SAFETY ISSUE WHEN BACKING UP OR TURNING RIGHT. ADDITIONALLY, VISION IS TOTALLY RESTRICTED ON THE LEFT HAND SIDE.**
