I, AS WELL AS MANY OTHERS FIND MITSUBISHI MOTORS TO BE UNCARING AND UNWILLING TO INVESTIGATE THESE POTENCIAL PROBLEMS THAT CAN RESULT IN INJURY OR EVEN DEATH.**
