FIRE, STOPPED WORKING, NOW NEEDS MOTOR REPLACED; 2) ABS FAILED ON SNOWY ROADS CAUSING SINGLE-VEHICLE ACCIDENT TO FRONT LEFT OF VEHICLE; 3) RECALL ON FUEL VENT HOSE, WILL REPLACE; 4) FRONT RT.
