I WAS HAVING THE CAR TOWED AT THE TIME AND HE IS THE ONE TO BRING IT TO MY ATTENTION. I DID CALL GM AND THERE WAS A RECALL ON MY CAR AND THIS PARTICULAR PART HAD BEEN REPLACED AT 29,000 MILES.
