THE FAILURE OF THE CLOCKSPrING ASSEMBLY RESULTED IN THE AIR BAG LIGHT BEING ILLUMINATED, AND I'M ASSUMING THAT THE DRIVERS SIDE BAG WAS ALSO INOPERATIVE. THE HORN AND CRUISE CONTROL WERE DEFINITELY INOPERATIVE. I PURCHASED A REPLACEMENT CLOCKSPrING (\$75) AND INSTALLED IT MYSELF (2 HOURS). THE NATURE AND FREQUENCY OF THIS FAILURE WOULD SEEM TO WARRANT A RECALL, IN MY OPINION.
