TOOK DELIVERY NEW 3/11/1999. ON 2/10/200, @ 5400 MILES, DEALER PERFORMED SB 05-002-99, WHICH I THINK WAS TURNING THE FRONT ROTORS. ON 9/30/2000, @10,382 MILES, DEALER PERFORMED SB 05-01-00, FRONT ROTOR AND PAD REPLACEMENT. ON 7/2/2001, @ 14,768 MILES, DEALER TURNED FRONT ROTORS. ON 2/7/2002, @ 20,804 MILES, DEALER REPLACED FRONT ROTORS. EVERY 5000 MILES, THE FRONT ROTORS HAVE DEVELOPED UNACCEPTABLE LATERAL RUNOUT. THIS VEHICLE IS STILL ON ITS ORIGINAL TIRES (AND THEY LOOK PRETTY GOOD), BUT ITS THIRD SET OF FRONT BRAKE ROTORS. DEALER REPORTS CHRYSLER REP SAYS THIS IS THE LAST "GOOD WILL" BRAKE REPAIR ON MY VEHICLE. THIS IS A DESIGN PROBLEM. IT IS A SAFETY ISSUE.\*AK
