THE CHROME REFLECTIVE MATERIAL ON THE INSIDE OF THE HEADLIGHT ASSEMBLIES FLAKES OFF WITH AGE. THIS VEHICLE IS A 1996 MODEL, AND ALTHOUGH JUST OVER 5 YEARS OLD, THE REFLECTIVE MATERIAL HAS FLAKED OFF THE INSIDE OF THE HEADLIGHTS, MEANING THE BULB ONLY HAS THE BASE PLASTIC TO REFLECT OFF, WHICH MEANS OUTPUT IS VIRTUALL NOTHING. I CAN SEND YOU ONE OF THESE DEFECTIVE ASSEMBLIES IF YOU WOULD LIKE TO INSPECT IT.
