THE FIRST HEAD GASKET WAS REPLACED ON 3-8-1999 @30,886 MILES. THE SECOND HEAD GASKET WAS REPLACED ON 1-24-2002 @ 55,691 MILES. THEY WOULD NOT HELP COVER THE COST BECAUSE IT WAS LONGER THAN ONE YEAR EVEN THOUGH THERE WAS ONLY 24,000 MILES ON THE HEAD GASKET. I HAVE KEPT ALL RECEIPTS ON MY VEHICLE AND HAVE KEPT UP WITH ALL THE REQUIRED MAINTENANCE. THERE MUST BE SOME DEFECT INVOLVED.*AK
