WHILE MY WIFE WAS DRIVING THE CAR WITH OUR CHILD AT AROUND 25 MPH, THERE WAS A CATASTROPHIC FAILURE. THE CAR SLOWED DOWN AND STARTED SHAKING ALONG WITH LOSS OF STEERING CONTROL AND POWER INTO THE WHEELS. SHE MANAGED TO STEER THE CAR TO THE SIDE OF THE ROAD TO A STOP AND UPON VISUAL INSPECTION THE RIGHT FRONT WHEEL WAS TIPPED AND LOOKED AS IF IT HAD DECOUPLED FROM THE AXLE, AND THE FRONT SUSPENSION HAD DROPPED ON THE RIGHT SIDE. THE CAR HAD TO BE TOWED TO THE DEALER AND WHILE THE CAR WAS BEING LIFTED ON THE TOW TRUCK I NOTICED METALLIC SHAVINGS THAT LOOKED LIKE WEAR DEBRIS COMING OUT OF THE VICINITY OF THE FRONT RIGHT WHEEL.
