THIS CAR COMES WITH FIRESTONE WILDERNESS TIRES MADE ESPECIALLY FOR THE OUTBACK. AT ONLY 24000 MILES, I HAD A BLOWOUT IN WHICH THE COMPLETE LEFT SIDE OF THE TIRE DISINTEGRATED. A FEW MONTHS AFTER I BOUGHT THE CAR AND HEARD OF THE TROUBLE WITH FIRESTONE TIRES, I CALLED THE DEALER WHO ASSURED ME THAT THESE TIRES WERE SAFE AND NOT ON THE RECALL LIST. WHEN THIS DANGEROUS INCIDENT HAPPENED TWO DAYS AGO, I WENT TO A LOCAL FIRESTONE DEALER WHO TOLD ME HE COULD NOT GET THESE WILDERNESS TIRES, AND DIDN'T EVEN HAVE THEM IN HIS COMPUTER. HE WANTED TO BLAME SUBARU FOR THE FAILURE. I CALLED BOTH MY SUBARU DEALER AND THE HEAD OFFICE IN GEORGIA (SPOKE WITH MANAGER KEVIN TRIPLETT).
