EUROPEAN CARS TYPICALLY HAVE ONE REAR FOG LIGHT IN THE BACK. THIS IS USUALLY ONE OF THE BACK-UP LIGHTS. THE OLDS USES TWO VERY BRIGHT RED LIGHTS FOR THIS. MOST OF THE TIME, THIS LIGHTS ARE ON WHEN THEY SHOULD NOT BE.*AK
