### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

STEERING SOMETIMES SQUEALS/SQUEAKS AT END OF U-TURN WHEN STEERING WHEEL IS TURNED ALL THE WAY (LOCK TO LOCK CONDITION) AT ABOUT 10MPH. STEERING BEGAN TO SOMETIMES SLIGHTLY DRIFT TO THE LEFT EVEN ON FLAT ROADS WHERE PREVIOUS VEHICLE DID NOT. THIS FIRST OCCURED AT ABOUT 200 MILES. THE CONDITION WAS UNFORTUANTELY NOT NOTICED ON VEHICLE TEST DRIVE. AT ABOUT 3000 MILES ISSUE PERSISTS AND NOW SOMETIMES CLUNK IS FELT IN STEERING AT TIMES WHEN WHEEL IS TURNED AND STOPPING. THIS USUALLY OCCURS WHEN STEERING IS TURNED SHARP THEN VEHICLE IS STOPPED. STEERING ONCE FELT LOOSE AND FLOPPY SUDDENLY THEN SEEMED TO CORRECT ITSELF AFTER DRIVING FOR ABOUT 20 MILES. BROUGHT VEHICLE IN FOR SERVICE AT DEALER
