SEVERAL PASSENGERS HAVE NOTICED THIS INTERMITTENT BEEPING THAT SEEMS TO OCCUR FOR NO SPECIFIC GIVEN REASON OR TIME. THE BEEP IS ALWAYS THE SAME VOLUME, TONE AND SOUNDS LIKE SOME TYPE OF BMW OR HONDA ANTI-THEFT DEVICE THAT BEEPS INSTEAD OF CHIRPING A SIREN OR HORN. THIS JUST OCCURS SOMETIMES FOR NO SPECIFIC REASON AND I HAVE NOT BEEN ABLE TO INVOKE IT. SEVERAL PASSENGERS THOUGHT IT WAS AN ANTI-THEFT DEVICE. THE INTREPID HAS KEYLESS ENTRY BUT NO ANTI-THEFT DEVICE AND HAS STOCK BASE CD PLAYER. I HAVE TR
