AFTER CHANGING THE OIL THE SERVICE WRITER TOLD ME THAT THE EMERGENCY BRAKE COULD NOT BE ADJUSTED BECAUSE IT HAD BEEN WORN DOWN DUE TO THE FACT IT HAD BEEN LEFT ON. I PROCEEDED TO TELL THEM THAT IT HAD NOT BEEN LEFT ON. AT THAT POINT THE MECHANIC CHIMED IN AND STATED THAT HE COULD PROVE THAT IT WAS LEFT ON.
