THROTTLE STUCK WIDE OPEN I HAD TO DEPRESS THE CLUTCH AND TURN THE ENGINE OFF. THIS HAS HAPPENED FIVE OTHER TIMES AT VARIOUS SPEEDS AND UNDER DIFFERENT WEATHER CONDITIONS. GM KNOW OF THIS PROBLEM IT HAS CAUSED ACCIDENTS AND THEY REFER YOU TO THE DEALER. THEIR DEALERS DO NOT HAVE A FIX FOR THIS PROBLEM AND THEY KNOW THIS INFORMATION. THIS PROBLEM IS SHOWING UP IN ALL F-BODY GM CARS WITH THEIR 5.7 LITER V8S. I HAVE NOT REPORTED THIS PROBLEM TO MY DEALER BECAUSE I KNOW THEY CAN NOT FIX IT. THIS IS A PROBLEM THAT IS NOT CONSISTANT. IT DOES NOT HAPPEN IF YOU PREFORM A GIVEN TASK. ONCE I STARTED MY CAR AFTER IT WAS SITTING ALL DAY THE TACH RACED FROM 900 RPM TO 4,000 RPM. I SHUT THE ENGINE DOWN AND RE
