DEALER SAID FAULTY, WARPED ROTORS AND REPLACED THEM FREE B/C IT WAS A MANUFACTURER'S DEFECT. FEW MONTHS LATER, APRIL 2001, THEY DID IT AGAIN. TOOK BACK TO DEALER, THEY REFACED THE FAULTY ROTORS, PUT NEW PADS IN, CHARGED ME \$300. IN JAN. 2002 BRAKES DID IT AGAIN.
