**ROTORS KEEP WARPING EVERY 6000 TO 1000 MILES. DAIMLER CHRYSLER WILL NO LONGER REPAIR/REPLACE THE ROTORS. THIS IS A SAFETY ISSUE. THE STEERING WHEEL VIBRATES WILDLY AND YOU HAVE TO HOLD ON AND I'M SURE IT IS NOT BRAKING PROPERLY DUE TO THE WARPAGE. THEY CONTINUALLY GET WORSE UNTIL YOU CANNOT DRIVE THE JGC UNTIL THEY ARE REPLACED. THERE WAS AN EARLIER RECALL ON THESE AND DAIMLERCHRYSLER HAS NOT FIXED THE PROBLEM. THEY SHOULD BE MADE RESPONSIBLE FOR THE ROTORS UNTIL THEY COORECT THE PROBLEM. THE RECALL SHOULD CONTINUE ON EVERY JGC UNTIL THEY FIX THE PROBLEM. THEY SHOULD NOT BE ALLOWED TO PUSH THE REPLACEMENT COST OF REPLACING THE ROTORS OFF ONTO THE CONSUMER.THEY SHOULD NOT BE ALI**
