INTERMITTENT WINDSHIELD WIPER MOTOR FAILURE STARTING AFTER PURCHASING VEHICLE USED IN AUG. 1999. REPLACED WIPER MOTOR FEB. 22, 2002, AFTER WIRING REPAIRS FAILED TO CORRECT THE PROBLEM. FAILURE HAPPENED SEVERAL TIMES WHILE DRIVING IN RAIN AND SNOW CAUSING US TO PULL OVER TO THE SIDE OF THE ROAD IN DANGEROUS CONDITIONS, INCLUDING ONE BLIZZARD. AFTER WIGGLING WIRES OR POUNDING ON THE WIPER MOTOR IT USUALLY WOULD WORK FOR A WHILE. HAVE HAD OTHER OWNERS OF CHEVY SUBURBANS AND TRUCKS TELL US THEY HAD THE SAME TROUBLE.*AK
