FOR THE THIRD TIME (18K MILES, 79K MILES, 129K MILES) THE INTAKE MANIFOLD GASKET HAS FAILED AND ALLOWED THE ENGINE TO LIQUID LOCK BY FILLING WITH COOLANT. FIRST INCIDENT COVERED BY WARRANTY, SECOND COST ME \$1,000 AND NOW PONTIAC IS WILLING TO SPLIT THE COST OF THE THIRD REPAIR. I CONTEND IT IS A DESIGN DEFECT, AND SHOULD COST ME NOTHING.\*AK
