NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE CHECK ENGINE LIGHT CAME ON AFTER THE CAR WAS IDELING VERY ROUGH. O'RIELLY CHEVROLET SAID THAT THE #5 INJECTOR WAS STICKING, THEY FLUSHED THE SYSTEM & REPLACED THE FUEL FILTER FOR \$207.73. TWO WEEKS LATER ON 2-25-02 THE CHECK ENGINE LIGHT CAME ON AGAIN. I TOOK TO O'RIELLY CHEV. & THEY SAID IT WAS THE #5 & #3 INJECTOR HAD TO BE REPLACED. THE FIRST TIME THE #5 INJECTOR WAS STICKING THE SERVICE REP. SAID IT WAS BECAUSE I WAS USING CHEAP GAS. I CHANGED THE TYPE OF GAS TO CHEVRON & AFTER TAKING ANOTHER TRIP, I HAD THE SAME SYMPTOMS & AFTER TAKING THE CAR TO O'RIELLY CHEV. THE #5 & #3 INJECTORS HAD TO BE REPLACED. THE TOTAL COSTS OF REPAIRS FOR BOTH TIMES IS \$717.88. I DON'T RECALL, OTHER THAN THE LEVEL OF OC
