PROCEEDING DOWN STEEP HILL AT NIGHT APPROACHING A T INTERSECTION, ENGINE QUIT RUNNING. ATTEMPTS TO RESTART FAILED, JUST NARROWLY AVOIDED A COLLISION, MINIMAL BRAKES AND STEERING AVAILABLE. CONTACTED PERSONAL MECHANIC, EXPLAINED SITUATION. CHECKED FUSES, 30 AMP FUSE FOR POWERTRAIN CONTROL SYSTEM RELAY COIL/GLOW PLUG CONTROLLER HAD FAILED. MECHANIC ADVISED OPEN THE FUEL FILTER HOUSING, REMOVE FILTER, CHECK THE HEATER WIRE IN BOTTOM. IF LOOSE, SHORTED OUT FUSE, THEREBY SHUT DOWN ENGINE. FOUND THE SOLDERED WIRE LOOSE. REMOVED SAME FROM THE ASSEMBLY PER INSTRUCTIONS AND REPLACED THE FUSE. ENGINE STARTED. MECHANIC SAID HE HAS REPAIRED (4) FORD DIESELS WITHIN PAST FEW MONTHS WITH SAME
