NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE DRIVER SEATBACK FAILED AND FELL BACKWARD TO A FLAT POSITION AS I WAS STARTING TO MOVE FORWARD AT AN INTERSECTION. I HAD TO PROP THE SEAT IN POSITION SO THAT I COULD FINISH THE TRIP. I HAD THE SEAT BACK REPLACED AT A SATURN RETAILER. THE INCIDENT MADE ME DECIDE TO TRADE IN THE VEHICLE. WHEN I WENT TO MY INSURANCE WEB SITE TO REGISTER MY NEW CAR, A LINK CAME UP TO CHECK THE SAFETY PROBLEMS OF MY VEHICLE - THE 1995 SATURN. THE ONE RECALL MENTIONED WAS THE FRONT DRIVERS SEAT FALLING BACKWARD. I CONTACTED SATURN AND ASKED WHY I HADN'T RECEIVED A NOTICE AND WAS TOLD THAT MY VIN NUMBER WAS NOT ONE WITH A PROBLEM. THERE HAVE BEEN NO PROBLEMS WITH THIS SEAT BACK, IT WAS DUE TO AGE AND MILEAGE.
