AT THE TIME I PURCHASED THE VEHICLE, I COULD NOT AFFORD THE \$3000+ THE DEALERSHIP WAS ASKING FOR AN EXTENDED WARRANTY AND NO OTHER EXTENDED WARRANTY COMPANY THAT I'VE CONTACTED OFFERS EXTENDED WARRANTIES ON TWIN TURBO CARS. SO ALL OF THIS, ROUGHLY \$8000 IN THE PAST YEAR, HAS COME FROM MY POCKET, WHICH I'M STILL PAYING. IN THE ORIGINAL TRANSMISSION WITH THE CAR, THE SEALS WERE LEAKING ROUGHLY 2 MONTHS AFTER I BOUGHT THE CAR.
