DURING SLOW SPEED TURNS IN REVERSE OR FORWARD, STRANGE GRINDING AND HONKING NOISES COME FROM FRONT OF VEHICLE IN AXLE AND STEERING AREA. CAN ALSO FEEL THE GRINDING SENSATION. HAVE CONTACTED DEALER SERVICE DEPARTMENT SEVERAL TIMES AND AM TOLD THERE IS A PENDING RECALL FOR THIS PROBLEM, BUT THAT THEY HAVEN'T RECEIVED IT NOR HAVE THEY RECEIVED THE REPLACEMENT PARTS NECESSARY TO FIX THE PROBLEM. APPEARS TO BE VERY SIMILAR TO NHTSA TSB SERVICE BULLETIN NUMBERS 0300101A & 1900401 (NHTSA ITEM NUMBERS SB625612 & SB621896). WERE ASSURED BY SERVICE MANAGER THAT PROBLEM WILL NOT HARM VEHICLE IN LONG-RUN, AND THAT WE CAN DRIVE IT NORMALLY UNTIL RECALL ITEMS ARE RECEIVED AT S
