THE "SRS" SYSTEM WARNING LIGHT CAME ON AND STAYED LIT. I TOOK IT TO MY MECHANIC (A HONDA SPECIALIST) WHOSE COMPUTER TESTING INDICATED THAT THE SRS CONTROL UNIT WAS DEFECTIVE. HE STATED THAT HE HAD SEEN THIS PROBLEM NUMEROUS TIMES AND SUGGESTED I SPEAK TO HONDA HEADQUARTERS, WHICH I DID. PLEASE NOTE THAT A FRIEND WITH THE SAME MODEL CAR HAD THE SAME PROBLEM WITH SRS LIGHT STAYING ON. HAVING EXPLAINED THE PROBLEM AND CONCERNS OVER SAFETY ISSUES, I WAS TOLD THAT MY WARRANTY HAD EXPIRED AND THAT I MUST TAKE IT TO THE DEALER AND PAY FOR THIS VERY COSTLY PART (\$600+), AND THAT THEY MUST MAKE DIAGNOSIS THERE FOR HONDA TO CONSIDER "GOOD WILL" REIMBURSEMENT.
