TRACK BAR, PREMATURE EXCESSIVE SLACK IN STEERING, HARD TO KEEP IN OWN LANE ESPECIALLY ON UNEVEN PAVED SURFACES(STEERING WANDERING). REAR AXLE U-BOLTS, LOOSE ON INSPECTION CAUSING SHAKING FROM THE REAR AXLE DURING ACCELERATION AND DECELERATION, BOLTS WERE RETORQUED & PROBLEM REACCURED AFTER 20 MILES. THE BOLTS WERE LOOSE AGAIN.
