THIS IS A WIDESPREAD PROBLEM WITH VOLKSWAGENS FROM 1997-1999. I EVEN HAD A WINDOW REGULATOR AND MOTOR INSTALLED BRAND NEW OUT OF THE BOX THAT WAS FAULTY. HELP. *AK
