WAS INSTRUCTED TO TAKE VAN TO DEALER AND DID SO MANY TIMES FOR REPLACEMENT OF PARTS IN THE DOOR. FINALLY WAS INFORMED OF A RECALL ON THE RECALL.. CAMPAIGN # 01V264000... DATED IN OCTOBER 2001... LOCAL DEALER COULD NOT GET PARTS, SINCE I LIVE IN FLORIDA FOR WINTER MONTHS WAS TOLD BY PONTIAC CUSTOMER RELATIONS TO TAKE THE VAN TO CARL'S PONTIAC, STUART, FL.
