ON INSPECTION, THE NO STEEL WIRES WERE FOUND IN THE SIDEWALL, EVEN THOUGH SPECS CALL FOR THEM ("SB-R"). AM VERY CONCERNED ABOUT THE SAFETY OF THE REMAINING 3 TIRES, AS WELL AS THE ONE NEW ONE. I TOOK DIGITAL CLOSE-UP PICTURES OF TIRE, AND CAN FORWARD THEM BY E-MAIL. MICHELIN HAD NO RECOMMENDATIONS, OTHER THAN TO SAY THEY WOULD CALL ME IF THEY GOT THE TIRE IN FOR QUALITY ANALYSIS. ON INSPECTION, THE NO STEEL WIRES WERE FOUND IN THE SIDEWALL, EVEN THOUGH SPECS CALL FOR THEM ("SB-R"). AM VERY CONCERNED ABOUT THE SAFETY OF THE REMAINING 3 TIRES, AS WELL AS THE ONE NEW ONE. I TOOK DIGITAL CLOSE-UP PICTURES OF TIRE, AND CAN FORWARD THEM BY E-MAIL. MICHELIN HAD NO RECOMMENDATIONS, OTHER THAN TO SAY THEY WOULD CALL ME IF THEY GOT THE TIRE IN FOR QUALITY ANALYSIS.
