ON 6/14/1999 I TOOK MY CAR TO THE DEALER FOR WARRANTY WORK.(35,784 MILES) BUSTED FRONT MOTOR MOUNT., RATTLING WHEN CHANGING GEARS, WATER IN TAIL PIPE WHEN IT RAINED AND HIGH RPM, EVEN WHEN IDLING. THEY TOLD ME THERE WAS NOTHING WRONG WITH THE MOTOR MOUNT, THE HIGH RPM WAS NORMAL. THEY COULD FIND NO RATTLE AND NO PROBLEM WITH EXHAUST PIPE. I DEMANDED A REFUSAL IN WRITING ON THE MOTOR MOUNT. THEY ASKED TO KEEP THE CAR ANOTHER DAY AND RECHECK THE MOTOR MOUNT AND IT WAS NOW RAINING, THEY'D RECHECK THE EXHAUST PIPE NOISE. THEY SAID THEY REPLACED THE MOTOR MOUNT, BUT I COULD FIND NO EVIDENCE THAT THEY HAD ACTUALLY REPLACED IT. BEING FEMALE, WE ARE REGARDED AS MECHANICALLY IGNORANT A
