**AUTOMATIC CLIMATE CONTROL AIR TEMPERATURE IS REGULATED BASED ON AMBIENT TEMPERATURE (I.E.: IF EXTERIOR TEMPERATURE IS 75 DEGREES AND CLIMATE CONTROL IS SET TO 70 - THE AIR CONDITIONER WILL ENGAGE.) THE EXTERIOR TEMPERATURE GAUGE ON THE AUTOMATIC CLIMATE CONTROL REGULARLY DISPLAYS AN INACCURATE EXTERIOR TEMPERATURE OF LESS THAN 60 DEGREES (EVEN ON 100+ TEMPERATURE DAYS.) IF THE SYSTEM REPORTS AN EXTERIOR TEMPERATURE OF LESS THAN 60 DEGREES, THE AIR CONDITIONER CANNOT BE MANUALLY ENGAGED - THIS MALFUNCTION RENDERS THE AIR CONDITIONER USELESS. FURTHERMORE, IF THE EXTERIOR READING IS LESS THAN 60 DEGREES, THE AUTOMATIC CLIMATE CONTROL WILL INCREASE THE TEMPERATURE OF THE CIRCULATING**
