LOST REVERSE GEAR ON TRANSMISSION. TOOK TO THE NEAREST TRANSMISSION SHOP. OWNER SAID A PIECE HAD BROKEN APART IN THE TRANSMISSION, WEARING A GROOVE IN THE REVERSE CYLINDER. THE TRANSMISSION WAS FULL OF METAL PIECES. AFTER A \$2000 REPAIR, FORD TELLS ME THAT THEY WON'T HONOR ANY WORK DONE AT A NONE FORD REPAIR SHOP. I BELIEVE THAT THIS DEFECT HAS BEEN SEEN IN OTHER TRANSMISSION FAILURES IN THESE VEHICLES. *AK
