OIL FILTER ON THE 1995 MERCURY VILLAGER WAS DAMAGED TWICE. ON 1/12/2002, MY WIFE WENT INTO THE PARKING LOT AT H.E.B AT THE CORNER OF EL CAMINO REAL AND BAY AREA BLVD. MY WIFE FELT THE BOTTOM OF THE VAN SCRAPE THE GROUND AS SHE WENT OVER A SMALL PAVED HILL AT THE ENTRANCE TO THE PARKING LOT. WHEN SHE GOT OUT OF THE VAN, SHE NOTICED THE OIL WAS LEAKING REAL BAD.
