### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I WAS GOING 55 MPH ON BELTWAY. I DISCOVERED THAT MY BRAKES WERE VERY HARD TO PUSH AND COULD NOT STOP. PULLED OFF TO SHOULDER AND COULD NOT PICK UP ANY ACCELERATION. I HAD THE CAR TAKEN IMMEDIATELY TO DEALER FOR CHECK-UP. THE DEALER (FOX) ADVISED THAT THE BRAKE BOOSTER HOSE FROM THE MASTER BRAKE CYLINDER BECAME LOOSE AND WAS "CRIMPED" NEAR THE HOOD AND FIRE WALL. THIS RESULTED IN THE FLOW OF VACUUM PRESSURE BEING COMPROMISED AND STOPPING. THE DEALER ADVISED THAT THE BRAKE BOOSTER HOSE HAD TO BE "REPOSITIONED." THIS CORRECTED BOTH PROBLEMS OF FAILED BRAKING AND LACK OF ACCELERATION. THE DEALER WOULD NOT OR COULD NOT FULLY EXPLAIN IF THIS WAS A MANUFACTURING PROBLEM OR WAS A RESULT
