RIGHT FRONT INSIDE BRAKE PAD LOCKED AGAINST THE DISC CAUSING CONTINUOUS WEAR. I WAS INFORMED BY THE SERVICE MANAGER THAT THE INSIDE PADS DO NOT HAVE "SQUEALERS" AS DO THE OUTSIDE PADS SO THERE WAS NO ADVANCE INDICATION OF IMPENDING FAILURE. DAIMLER/CHRYSLER HAS INFORMED ME THEY WOULD HAVE TO DECLINE MY REQUEST FOR CONSIDERATION IN THIS MATTER BECAUSE THE VEHICLE HAD JUST EXCEEDED THE TIME/MILEAGE LIMITATIONS OF THE MANUFACTURER'S WARRANTY AT THE TIME (\$357.78) EXPENSE WAS INCURRED.*AK
