I AM 6'0". WHEN DRIVING MY HONDA S2000, MY LEFT TEMPLE IS LEVEL WITH AND ONLY A FEW INCHES FROM THE CONVERTIBLE ROOF FRAME. THIS IS A STEEL ROD STRUCTURE, WITH SHARP EDGES. ON TURNING INTO AND OUT OF MY DRIVE, I FREQUENTLY IMPACT MY LEFT TEMPLE ON THIS NONPADDED STRUCTURE. I CONTACTED HONDA THROUGH CONSUMER LINE AND THROUGH THE LOCAL SERVICE DEPARTMENT. THEY SAID THAT THEY COULD NOT HELP. WHILE I AM NOT AN ENGINEER, IT SEEMS THAT REPLACING THE SEATS WITH OTHERS THAT SIT THE DRIVER LOWER, OR SIMPLY LOWERING THE EXISTING SEAT WOULD SOLVE THE PROBLEM.
