I WAS TRAVELING ON THE HIGHWAY AT ABOUT 65 MILES PER HOUR WHEN THE STEERING WHEEL WAS JERKED OUT OF MY HANDS. THE TRUCK BEGAN TO SWERVE AND VIBRATE, AND I REALIZED A TIRE HAD BLOWN OUT. I DID NOT SEE ANYTHING I COULD HAVE HIT ON THE ROAD NOR DID I FEEL LIKE I HAD HIT ANYTHING. I CHANGED THE TIRE AND TOOK THE BLOWN TIRE TO MY LOCAL GOODYEAR DEALER WHO EXAMINED IT AND CONFIRMED THAT THE TIRE HAD NOT BEEN CUT OR PUNCTURED AND CONCLUDED THAT I WAS RUNNING LOW TIRE PRESSURE AND THEREFORE, EVEN THOUGH THERE IS ONLY 17% TREAD WEAR I WAS ENTITLED TO ONLY A 50% ADJUSTMENT ON THE TIRE.
