AT LESS THAN 70,000 MILES I HAD TO REPLACE THE TRANSMISSION ON MY 1997 CHEV EXT-CAB 4 WHEEL DRIVE TRUCK. THAT WAS IN SEPTEMBER OF 2000. NO REAL EXPLANATION FOR THE REASON IT WENT OUT. THEY CALIM MILES DRIVEN. THE PREVIOUS YEAR, JUNE 1999, WITH LESS THAN 50,000 MILES ON THE TRUCK, THEY TOOK THE TRANSMISSION OUT AND TORE IT APART TO FIND OUT WHAT WAS CAUSING A SLIPPING PROBLEM. THEY FINALLY SETTLED ON A VALVE THAT HAD GONE BAD. ONE WEEK LATER THEY HAD TO REPLACE THE SAME VALVE AGAIN. IN 2000, I THOUGHT THE TRANSMISSION MY OF HAD A PROBLEM DUE TO THE SERVICE PEOPLE TAKING THE TRANSMISSION APART THE PREVIOUS YEAR. THEY DENIED THAT WAS THE PROBLEM. WE HAD TO PURCHASE A BRAND NEW TRANS
