YESTERDAY I HAD A 4 WHEEL COMPUTERIZED ALIGNMENT PERFORMED. IT WAS DIFFICULT AND SOMETIMES ALMOST IMPOSSIBLE TO TELL THE CAR WAS OUT OF ALIGNMENT BECAUSE IT WOULD DRIFT TO THE LEFT OR RIGHT. THAT NIGHT WHEN PULLING OUT AWAY FROM FRIENDS HOUSE, HAVING WHEEL TURNED SHARP AND WAITING AT IDLE SOMETHING IN THE FRONT END WAS VIBRATING AND IT WOULD CHANGE WHEN WHEEL WAS MOVED. LATER THAT NIGHT STEERING WHEEL TIGHTENED UP AS IT HAD BEFORE ALL OF A SUDDEN WHEN DRIVING. WHEEL WAS REALLY DIFFICULT TO TURN ALL OF A SUDDEN, STEERING BECAME MUCH MORE SENSITIVE ALL OF A SUDDEN WHERE IT PREVIOUSLY WAS NOT. WHEN BRAKING OR ACCELERATING WHEEL WOULD FEEL EVEN MOVE DIFFICULT TO TURN AND ALM
